THE HOA BOARD LETTER

Things are looking up. Look around the neighborhood and you will see some changes.

The parking issue is almost resolved. Prescott has been busy writing courtesy and hearing letters and most homeowners are complying with the CC&R's. A great big THANK YOU to all those homeowners who are cooperating.

Landscaping of the common areas looks good. Landscaping of individual homes is almost complete. Prescott wrote 39 letters last month to homeowners who have not had their paperwork completed. The Design and Review Committee has completed over 20 inspections so far. The next area we will concentrate on is painting or staining of fences. We are making progress.

Painting of the clubhouse was completed last month. New pool furniture is on order and should be here in about four weeks.

Security is a big issue with many homeowners. Your Board is in the process of having several security firms make proposals regarding what we can and should do to make Mountain View more secure. We want to make sure we are spending your money in the most cost effective way. Remember, just because we live in a gated community does not make it secure. We each have a responsibility to ensure our own homes are as secure and as safe as we can make them.

Please read the "Did You Know" column this month. In the March Newsletter we published the pool rules, the April Newsletter contained the parking rules, and the May Newsletter covered the over-55 age restriction rules. This month's column is a summary of those three areas.

I don't know if everyone is aware of this, but there are many people in this community who volunteer their time to keep this place running. The pool and spa don't just remain full all of the time and at the correct temperature—someone has to do it. The luncheons and dinners don't just happen—a lot of work goes into the planning and preparation. All of the committees don't just happen—homeowners volunteer to make them work. I thank all the people who work so hard and give of their time to continue to make Mountain View a "Great

DID YOU KNOW?

Each month we are writing a DID YOU KNOW column to cover rules and regulations. Hopefully by the end of the year, we will have covered all of the major areas regarding common facilities use, parking, landscaping, signs, etc. This month's column is summary of the March, April, and May columns.

POOL & SPA RULES

1. Guests must be accompanied by the hosting homeowner/resident. The maximum number of guests is six (6) per residence. *Our pool and spa have a maximum of 30 and 10 people, respectively, and we have 255 homes with at least one resident per home.*
2. Individuals under the age of 14 years are not allowed in the spa. (Health Code) *This is State law and we have no choice. Spa water temperatures can be very harmful to children under age 14, especially infants.*
3. Individuals under the age of 14 years are not allowed in the pool unless accompanied by a responsible adult of 21 years of age or older. *This is a safety issue.*
4. Incontinent persons, including those in diapers or children who are not toilet trained, are not allowed to use the pool. *This is a health issue.*
5. Use the pool and spa facilities at your own risk. The Association does not employ a lifeguard or other personnel to monitor activities at the pool and therefore cannot be held liable for any injury or damage that may occur.

PARKING RULES

1. Authorized Vehicles owned or operated by the Owner and kept in the Properties must be parked in the garage to the extent that spaces are available. Each Owner shall ensure that their garage has space available for two Authorized Vehicles.
2. If an Owner has two Authorized Vehicles parked in the garage, then the Owner may park additional Authorized Vehicles in the driveway if they do not restrict the passage of pedestrians or vehicles over driveways, streets or sidewalks, or extend beyond the space in which they are parked. The driveway includes those extensions which were approved by the Design and Review Committee.
3. If an Authorized Vehicle will not fit in the garage because the Authorized Vehicle is oversized or because there are already two Authorized Vehicles in the garage, then the Oversized Authorized Vehicle can be parked in the driveway. An Oversized Authorized Vehicle is defined as an Authorized Vehicle which is too high or long to fit in the garage as originally built by the Declarant (without shelves, cabinets, workbenches, storage devices, etc).
4. Prohibited Vehicles may only be parked in closed garages or parked for 48 hours in any five-day period for loading, unloading, making deliveries, or emergency repairs.

WHO CAN LIVE IN MOUNTAIN VIEW

1. This is an over 55 age restricted community.
2. Each lot shall be used as a dwelling for a single family and for no other purpose.
3. Each occupied residence shall be permanently occupied by one or more Qualifying Residents. A Qualifying Resident is a person who is 55 or older.
4. For purposes of qualification under state and federal law governing senior housing, permanent occupancy shall mean that a Qualifying Resident considers the residence to be his or her legal residence and resides on the Lot for at least 6 months during every calendar year.

MEETING HIGHLIGHTS—JUNE 15, 2005

Financial Report: May financials were approved by the Board. A meeting with the Financial Committee, Board of Directors and Prescott will be scheduled to discuss 2005/2006 budget, procedures, and payment schedules.

Management: Joanne Phillips reported that the Moreno Valley Police Department has been given the gate code to enter into police car computers for easy access to the development.

Landscape: David Lydyoff reported two slope areas need plant replacement. Gopher treatment is ongoing. Board requested a meeting with the Moreno Valley Ranch Golf Course and Prescott to discuss sprinkler problems. Spotlights on each entrance palm tree will cost approximately \$100 per tree.

Design and Review: Eighteen to twenty Inspection/Notices of Completion have been generated. Development is looking good.

Social Club: Newly elected Social Club Officers were introduced: Jo Pavlik, Chair; Sharon Cristino, Vice Chair; Marilyn Dawson, Secretary; and Godfrey Asciak, Treasurer. June's TGIF will be an appreciation celebration for all of the volunteers who participated in Social Club activities for the past year. Fourth of July activity will be a potluck and silent auction.

Web Page: Committee will meet in July to discuss password ability for the web page. Location and installation of a donated computer will also be discussed.

Homeowner Input: Mike Noon presented a petition from residents regarding security issues in the development. The Board of Directors is working on these issues with various security companies.

Unfinished Business: Monument lettering is pending. Two additional bids are needed. The "Ryland" name will be removed from the Cactus Street entrance. Proposal for Community Garage Sales was tabled.

Required Board of Directors Decision: Approval of 2005/2006 Budget was tabled until a meeting is held with the Finance Committee, the Board and Prescott. New Social Club officers were approved. Approved the purchase of pool furniture – 5 tables, 25 chairs and 12 lounge chairs in the amount of \$9975.50.

New Business: Mr. Kyung Son presented a proposal for security cameras for Board's review. Approval was granted for the Social Club to be the recipient of all clubhouse rental income, including income for 2004/2005 fiscal year. A resident received approval to extend parking of

MOUNTAIN VIEW DESIGN AND REVIEW COMMITTEE

Each month the Design Review Committee (DRC) will provide a few excerpts from our governing documents. The excerpt selection may come from concerns by what has been observed in the neighborhood or from a question of a homeowner. Subsequent inputs will come from members of the committee.

During the past month, I have received several inquiries about Prescott's letter to homeowners who had not completed their rear yard landscaping within one year of the date of purchase. Following are the answers to those inquiries.

1. ***Where can I obtain the required forms?***

If you need copies of these forms, they can be found on the Mountain View Website at www.mountainviewhoa.org. Once you are in the website, click on CC&R's. You will find the forms here. If you do not have access to the website, contact any member of the Design and Review Committee listed in the newsletter for a copy of the forms.

2. ***Are the forms necessary?***

YES, the forms are required by the CC&R's and by the papers that you signed upon purchasing our homes. In the packet was a form that stating "you where to landscape your back yards within one year from the date of purchase". Per the CC&R's ALL homeowners are required to submit these forms, not only for the landscaping of the back yard but for any Structure or Landscape Improvements they are going to make.

The following forms are required for any structure and landscape improvements:

Mountain View Community Association Structure and Landscape Improvement Application

This application is to be completed by the homeowner. The homeowner must obtain the signatures of the neighbors, attach three (3) copies of a drawing showing all improvements, complete the DCR Approval form and attach a check for \$100. The homeowner is to mail these two (2) forms to:

DCR Approval Form

The homeowner is to complete the top two (2) lines of this form and submit it along with the Structure and Landscape Improvement Application.

Notice of Completion

The top portion of this form is to be completed by the homeowner and mailed to the address above only **UPON COMPLETION OF ALL IMPROVEMENTS.**

3. ***Who is required to submit the forms?***

It is the responsibility of the **homeowner** to submit all required forms.

THE GARDENER'S CORNER

From the gardener's corner...July is one of our hottest, driest months. Summer heat is upon us, but Fall's cool weather is ahead and we should be planting our cool weather gardens too. Pinch back **herbs** to encourage branching and use the clippings fresh or dry them. Their flavor is at their peak early in the morning after the dew has dried, but before the day becomes warm and the fragrant oils dissipate.

Keep **citrus and avocado trees** well watered throughout the summer. Build a water basin to soak in deeply, but start it one foot away from the trunk to prevent crown rot.

Fill in garden gaps with summer-into-fall bloomers, especially alyssum, celosia, cosmos, petunia, portulaca, red sage, vinca and zinnias.

Encourage repeat blooming by **pinching or cutting back** coreopsis, crape myrtles, dahlias, delphiniums, lobelias, petunias, salvias and verbenas.

Continue **pruning spent blooms on roses** weekly or so until fall. Water only in the mornings to lessen mildew and other disease problems. Speaking of rose problems, if you have **black spot on your roses** try Jerry Baker's potion to combat this problem: 15 tomato leaves, 2 small onions, ¼ cup rubbing alcohol. Blend in blender and add 1 gallon of soapy water. Apply with pump sprayer every 7-10 days. Mary Kimberlin tells me it works for her!

Dig and **divide bearded iris** clumps if they are crowding each other or didn't bloom too much this year. Break off and discard the older central rhizomes that have no foliage. Let the young healthy rhizomes dry out of the direct sun for a few hours so a callus forms over the break before replanting it. On rhizomes with foliage, clip roots to two inches, and clip the remaining foliage to about an eight-inch fan. Dig compost and

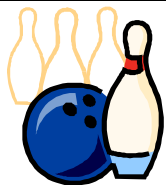
WHAT IS A SILENT AUCTION?

What's Cooking?

HI all! As promised, here are the recipes from the TEA. I know the ladies know how very much we enjoyed it and truly appreciated the hard work and talent for making it so beautiful. One more THANK YOU.....

LEMON SQUARES (Judy Kathriner)

Preheat oven to 350

Mix together:

1 cup butter, 1/2 cup powdered sugar and 2 cups flour.

Press into 13x9 pan and bake @ 350 for 15 minutes or until lightly golden.

While shell is baking, mix together:

5 eggs, 2 cups sugar, grated rind of 2 lemons and 4 Tbsp lemon juice.

Beat slightly and pour over hot crust. Bake 20 Minutes @ 350.

PEA SALAD (Joanne Phillips)

4—10oz packages frozen peas, thawed

1 cup chopped green onions

1 cup chopped celery

salt and pepper to taste

1 pint sour cream

1 lb bacon, cooked and crumbled

1 small can of cashews

Thaw and drain peas. Combine with onions, celery, sour cream, salt and pepper. Cover and marinate in refrigerator at least 2 hours. Just prior to serving, toss salad with bacon and cashews.

CHILLED PEACH SOUP (Sue Janssen)

8 cups pitted peaches

1 vanilla bean

1 cinnamon stick, split

2 Tbsp star anise

1 orange (peel and juice)

1/2 lemon (peel and juice)

1/2 lime (peel and juice)

2 Tbsp lemon balm, lemon verbena or lemon grass

1 cup non-carbonated spring water

2 cups cranberry juice

1/2 cup champagne

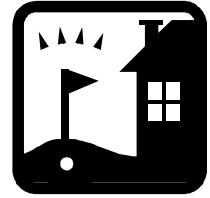
simple syrup to taste (recipe below)

In large pot, place peaches, vanilla bean and bouquet garnish (cinnamon, star anise, orange, lemon and lime peels, and lemon balm, verbena or grass). Add citrus juices, spring water, cranberry juice and bring to a boil. Simmer 10 minutes. Remove vanilla bean and bouquet garnish. Puree in small batches, as the mixture is hot. Add the champagne and season with simple syrup to taste. Chill for at least 1 hour before serving.

SIMPLE SYRUP:

Stir 1 cup sugar and 1 cup water in small saucepan, over medium heat, until sugar is completely

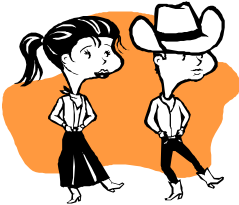
